### **Conquering Data Transformation** in a Regulated World

Groupe BPCE (BPCE) is the second-largest banking group in France. Through its 100,000 staff, the group serves 35 million customers - including individuals, professionals, companies, investors, and local government bodies - worldwide. BPCE was already compliant with Basel II regulations, which require robust data management to reduce systemic risk in the banking sector. While BPCE had established strong foundational practices and had robust technologies in place including ad-hoc data catalogs, governance frameworks, quality controls, and lineage tracking—its technology stack had grown unwieldy. Instead of fostering collaboration, it created data silos, making it difficult for teams to find, understand, and use data effectively.

Supervisory authorities demanded greater transparency into data. BPCE needed to catalog and visualize data flows. understand the origins of data, and track how information moved across systems and teams. The complexity of the IT environment and the proliferation of tools made it challenging to efficiently meet regulatory requirements and support business needs. The organization recognized the need for a new, more agile approach to data governance and data cataloging.

Implementing effective data management and governance in a highly regulated industry.

#### Solution
